If you have a card on file with us, you can let us know and we can charge that card for your summer tuition. Otherwise, you will be emailed an invoice to the email address on your registration form. Weekly Summer Dance Classes – June 21-July 14 on Tuesday and Thursday

You can register for the whole summer, by the week, or drop-in (if space is available). Cost is calculated based in how many classes you take in a week. For example, if you take Ballet on Tuesday and Jazz on Thursday, that is considered two classes. If you take Ballet and Lyrical on Tuesday, and Ballet on Thursday, that is 3 classes. Sibling discount will apply to weekly summer classes only.
